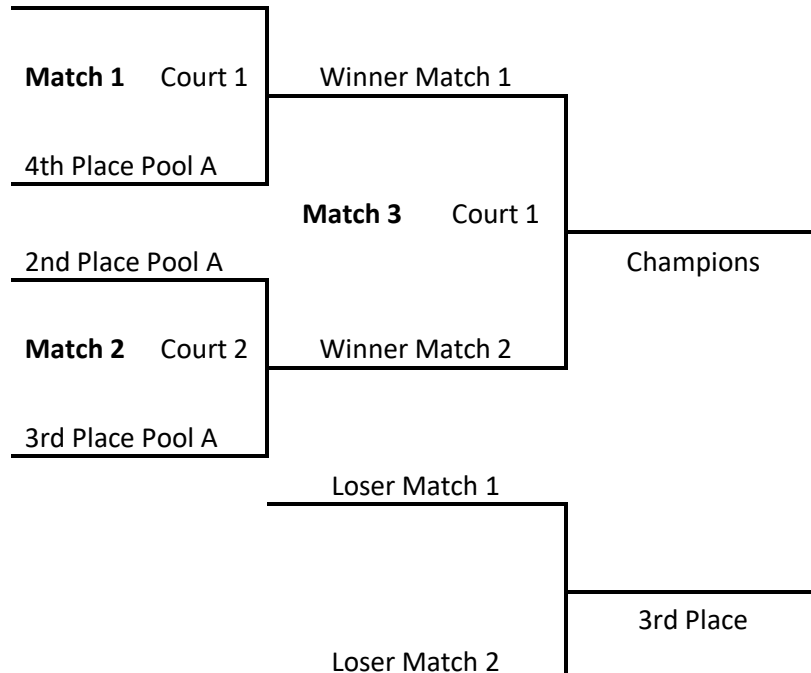

<b>Team Areas:</b>	Teams will be allowed to camp in open areas at the playing sites. Teams <b><u>must</u></b> clean their camp area before leaving the facility.
<b>Concessions:</b>	Limited concessions will be available including beverages, sub sandwiches, chips, candy bars and protein bars.
<b>Coaches Meeting:</b>	See time frame above for each division.
<b>Rules:</b>	USAV rules will apply except: 12s teams will use the volley-lite balls and a short service line, 7'0" into the court and different liberos may be designated for each set. 12's coaches will decide at the coaches' meeting if they would like to limit the number of serves per server.
<b>Pool Play:</b>	Matches will be best 2 of 3, first two sets to 25 capped at 27, 3 <sup>rd</sup> set to 15 pts capped at 17. Do not switch sides in any of the sets.
<b>Lunch Break:</b>	There will be a 30 minute lunch/dinner break between pool play and playoffs for all age divisions.
<b>Playoffs:</b>	Matches will be best 2 of 3, first two sets to 25, 3 <sup>rd</sup> set to 15 pts. No point caps on any of the sets and do not switch sides between sets.
<b>Tie Breaker:</b>	Two way ties are decided based on head-to-head results. Three way ties are decided in the following order: set winning %; plus/minus points; coin toss.
<b>Awards:</b>	T-shirts for the tournament champions of each age division. Awards for 1 <sup>st</sup> place in all other divisions and 2 <sup>nd</sup> place in the Gold division.
<b>Equipment:</b>	Game balls will be provided.

### **Covid Protocol:**

- 1) We are being as cautious as possible so everyone's temperature will be taken as they enter the facility. Anyone with a temperature of 100.4 F or higher will be asked to leave.
- 2) Masks must be worn by everyone and at all times. We have a limited number of disposable face shields available for anyone that can't wear a mask.
- 3) We ask that everyone try to social distance as much as possible.
- 4) The locker rooms are not to be used. Rest rooms will be open.
- 5) Please bring your own water bottles. We have a non-contact water bottle filling station but it's filters can't keep up with heavy use. Bottled water will be on sale.
- 6) Due to COVID restrictions on preparing and handling food onsite we can only have limited concessions onsite. We will have a concession stand with pre-packaged food such as chips, candy bars and protein bars. Sub sandwiches and beverages will also be available at the concession stand.
- 7) Spectators- Because of COVID indoor occupancy restrictions, we are unable to allow spectators in the 14s, 16s and 18s divisions. While the Governor's most recent Executive Order allows spectators, it limits occupancy indoors to 150 people. The 14, 16 and 18s divisions are limited to 12 teams instead of the usual 16 in each division in order to stay under 150 people. With players, coaches and team reps we will be approaching the 150 person limit so spectators will not be allowed in these divisions. The 12s division only has 4 teams so we are allowing spectators in that division. We recognize that parents want to watch their kids play and some parents may be indispensable to team. If there is a parent that has to be there for medical reasons, to live stream the matches for other parents or whatever, you can designate them as a team rep and we will allow them to watch from the bench or off the court. I did not ask for rosters from the teams so I don't know who is a coach or team rep but please try to limit your team personnel to 12 people including players, coaches and team reps. I would like each team in the 14s, 16s and 18s divisions to email me a list with the name of that team's coaches and team reps. Players and people named on the list will be allowed to enter the facility
- 8) There will be three chairs set up on each side of the court, spaced 9' apart for team benches. Other team personnel must stand 6' apart.
