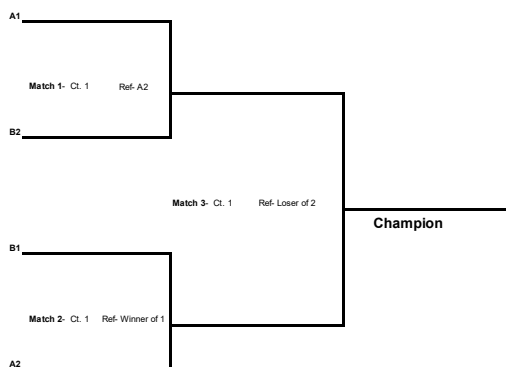

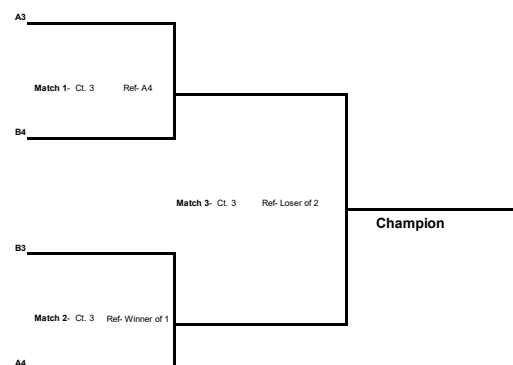

| Team Areas: | Teams will be allowed to camp in open areas at the playing sites. Teams <u>must</u> clean their camp area before leaving the facility. |
| Concessions: | Concessions will be available. No outside food allowed. |
| Coaches Meeting: | See time frame above for each division. |
| Rules: | USAV rules will apply except: 12s teams will use the volley-lite balls and a short service line, 7'0" into the court and different liberos may be designated for each set. The number of serves will be limited to 5 serves per server per term of service in the 12's division. 14s will be allowed to toss the serve and catch it or let it drop one time per term of service. 16 and 18 divisions will have 8 seconds to serve and no re-tosses allowed. |
| Tournament Format: | Teams in the 12's division will play 3 matches in pool play and at least 1 match in playoffs. Teams in all other divisions will play 2 matches in pool play and 2 matches in playoffs. Teams in the 14s, 16s and 18s divisions will either play or ref the last round of play of playoffs so no teams can leave early in these divisions. Teams that lose Match 1 of playoffs in the 12's division do not have to ref and may leave early. |
| Pool Play: | Matches will be best 2 of 3, first two sets to 25 capped at 27, 3 rd set to 15 pts capped at 17. Do not switch sides in any of the sets. Teams will ref themselves in pool play in the 12's division and work teams will be scheduled to ref for playoffs. |
| Lunch Break: | There will be a 30 minute lunch/dinner break between pool play and playoffs for all divisions. |
| Playoffs: | Matches will be best 2 of 3, first two sets to 25, 3 rd set to 15 pts. No point caps on any of the sets and teams do not switch sides between sets. |
| Tie Breaker: | Two way ties are decided based on head-to-head results. Three way ties or two way ties in cross pools are decided in the following order: set winning %; plus/minus points; coin toss. |
| Awards: | T-shirts for the tournament champions of the 12,14,16 and 18's divisions. Awards for 1 st place in all other divisions and 2 nd place in the Gold division. |
| Equipment: | Game balls will be provided. |
| Communication Procedure: | If a team will be arriving late due to weather delays or other difficulties please call Doug Lothenbach @ <u>218-213-2880</u> . |

Covid Protocol:

- 1) We are being as cautious as possible so everyone's temperature will be taken as they enter the facility. Anyone with a temperature of 100.4 F or higher will be asked to leave.
- 2) Masks must be worn by everyone and at all times. We have a limited number of disposable face shields available for anyone that can't wear a mask.
- 3) We ask that everyone try to social distance as much as possible.
- 4) The locker rooms are not to be used. Rest rooms will be open.
- 5) Please bring your own water bottles. We have a non-contact water bottle filling station but it's filters can't keep up with heavy usage. Bottled water will be on sale.
- 6) Spectators- We are now able to allow a limited number of spectators. While the Governor's most recent Executive Order allows spectators, it limits occupancy indoors to 250 people. We have limited entries to 12 teams instead of the usual 16 in order to stay under 250 people and allow some spectators. With players, coaches and team reps and 10 spectators per team we will be approaching the 250 person limit. I would like each team playing this weekend to send a list with the names of that team's coaches, team reps and up to 10 spectators to Rob at rjfish13@yahoo.com . Because there are only 8 teams in the 12s division each team in that division will be allowed 20 spectators. Only people named on the list will be allowed to enter the facility. The admission fee will be \$10/person. Please email this list to Rob by Wednesday, April 28. Finally, in order to limit congestion in the building teams playing in the afternoon division should not show up any earlier than 2:30 pm and may be asked to wait in the parking lot or in their cars if the morning division is running late.
